3. Procedures:

- All venues are checked to ensure the flooring is suitable for dance (i.e. sprung floor or sports hall, no damage, no debris, cleaned to an adequate standard)
- All venues have suitable changing and bathroom facilities for both male and female students
- All venues are secure and access is only permitted to MPDA teachers,
 students and parents for the duration of the class
- All venues have access points for wheelchair users including lifts or ramps
- All venues have suitable heating and ventilation
- A suitable waiting area will be made available for parents at all venues
- NO jewellery to be worn by staff or students
- Long hair MUST be tied back
- Students MUST wear suitable dance attire and shoes where appropriate
- Dancing in socks is NOT permitted
- All large items like school bags must be kept in the changing facilities or with parents to avoid accidents. Water bottles and valuables are permitted.
- Fire exits MUST be clearly marked and left clear as all times³
- Parents of students under the age of 4 MUST stay on site for the duration of the lesson
